GENERAL MEMORANDUM FOR

ACADEMIC COOPERATION AND EXCHANGE BETWEEN ASEAN UNIVERSITY NETWORK (AUN)

AND KYOTO UNIVERSITY

The CHAIRMAN of AUN Board of Trustees and the PRESIDENT of Kyoto University hereby conclude an agreement for academic exchange and cooperation between the two organizations (referred to hereafter as 'the two parties').

- 1. The two parties will promote in particular the following activities in the field of sustainable energy and environmental studies for non-military purposes.
 - [1] Exchange of scientific materials, publications, and information
 - [2] Exchange of faculty members
 - [3] Exchange of students
 - [4] Joint research and meetings for research
- 2. These activities are to be carried out after mutual consultation between the two parties or the divisions concerned thereof.
- 3. All financial arrangements to pursue any of the above activities are to be negotiated for each specific case.
- 4. The two parties agree that, in the event of research collaboration leading to patent rights, copyrights and other intellectual property rights, a further agreement must be negotiated in each case in accordance with the policies of the two parties on intellectual property.
- 5. Amendment of this general memorandum is to be effected upon deliberation by the two parties.
- 6. This general memorandum does not restrict any activities under other MOUs among member universities.
- 7. This general memorandum shall be effective upon signature by the two parties and shall remain in force for a period of five years. Thereafter it shall be automatically renewed from year to year.
- 8. Termination of this general memorandum is to be effected upon deliberation by the two parties. However, after the initial period of five years either party may terminate the memorandum at the end of a given year by giving six months notice in writing of such intent.
- 9. The member universities belonging to AUN are listed in the below. When there is a change in membership, AUN shall immediately notify Kyoto University of the change.
- 10. This general memorandum is written in English.
