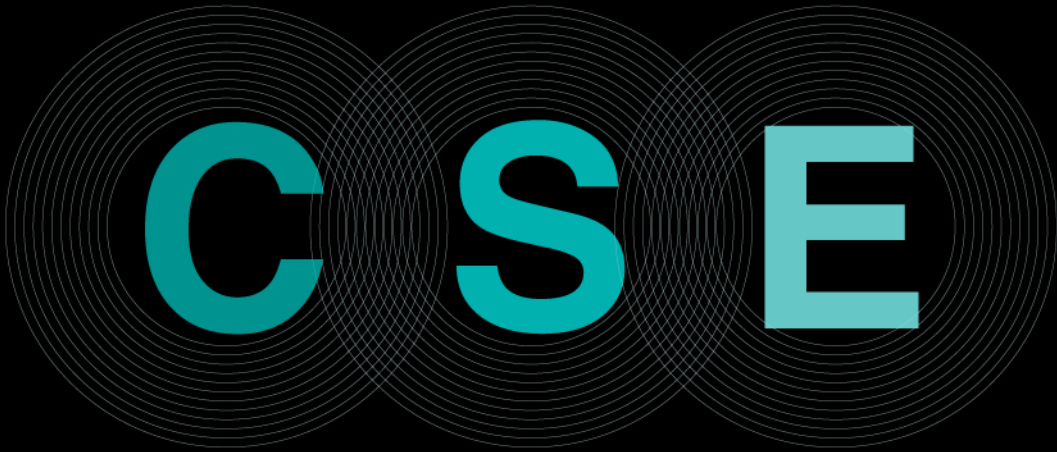

Scholarships from 14 AUN Member Universities were granted to AUN students from academic year 2009/2010 in order to increase the student mobility within AUN Member Universities. The scholarships varied from partial to full scholarship in different fields due to the scholarship's conditions from the host university. In 2009, **more than 70 students were awarded by this programme.**



International College Student Exchange Programme from ASEAN to the Republic of Korea (ROK)

20 Scholarships granted to ASEAN students in 2010. 20 students from 8 ASEAN countries namely, Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, the Philippines, Thailand, and Viet Nam were awarded to study in ICT area for one academic year 2009/2010 at Daejeon University, the ROK.





China-AUN Scholarship

Scholarships, both for Master and Doctoral programmes, are granted to students from 10 ASEAN countries annually. There is a significant increase in applications in recent years for China-AUN Scholarship. For academic year 2009/2010, 44 applications were received at the AUN Secretariat which 20 successful awardees commenced their studies at the admitting institutions in China in October 2009. For the latest opening of China-AUN Scholarship, 107 applications were received for academic year 2010/2011 in which China Scholarship Council (CSC) will announce selection result in July 2010.

At the closing ceremony, the paired universities from different countries presented their performances interpreting the meaning of city from their perspectives by using the technology and the mixture of their traditional arts.

IPNET-AUNIP Intellectual Property Training 2009, Alicante, Spain

Theme: IP and Innovation: Stimulating Opportunities for Universities



With the continuation of IP education cooperation, IPNET-AUNIP Intellectual Property Training 2009 was initiated and co-organised by AUNIP and IPNET programme of University of Alicante, Spain during 19-24 October 2009. It aimed to augment universities' capacity to manage intellectual property rights in research at strategic and implementation levels. With the short announcement, there were only 8 ASEAN participants from 5 AUN Member Universities and 2 Non-AUN Member Universities who received the training from European experts as well as had good opportunities to visit Research Units of University of Alicante, Office for Harmonisation in the Internal Market-Trade Marks and Design (OHIM) and Technological Transfer and Innovation Office of University Polytechnic Valencia.

AUN Actual Quality Assessment

Aware that ensuring quality education would also facilitate and enhance future mobility of labour/individual service providers within the region, the AUN has developed and promoted a quality assurance system as an instrument for maintaining, improving and enhancing teaching, research and the overall institutional academic standards of higher education of AUN Member Universities. Doing this, AUN Actual Quality Assessment at Programme Level has been initiated since 2007 and is now applied on the voluntary basis. During the year 2009, three Assessments were held in Indonesia and Viet Nam, respectively.

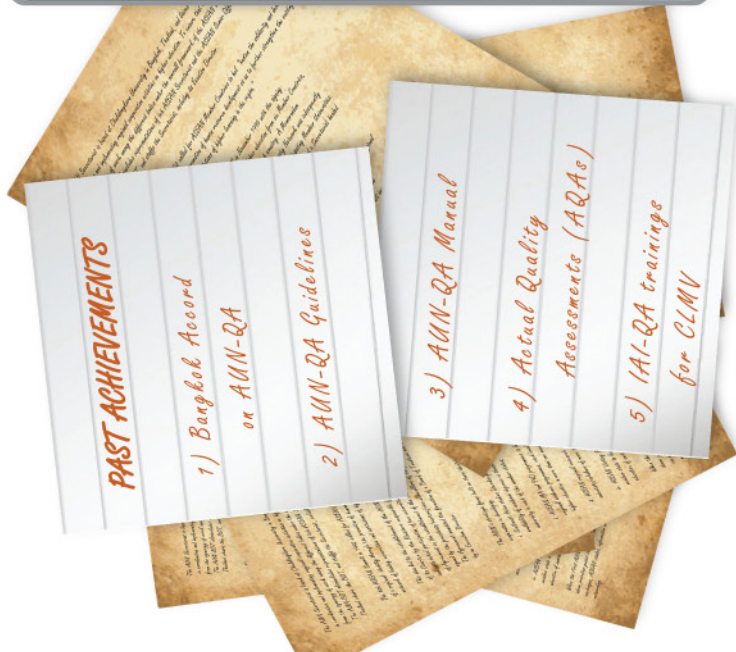
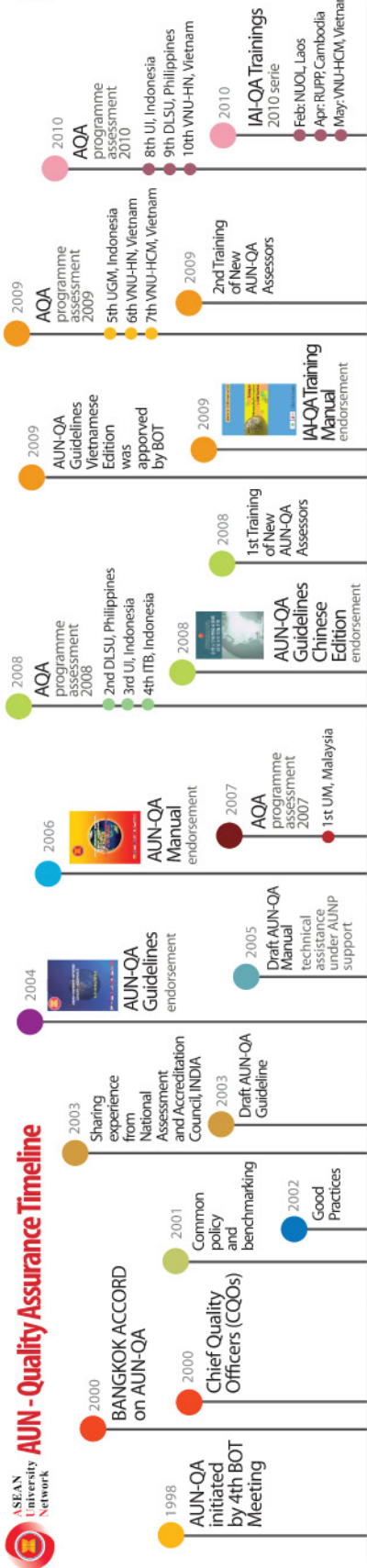

AUN - Quality Assurance Timeline



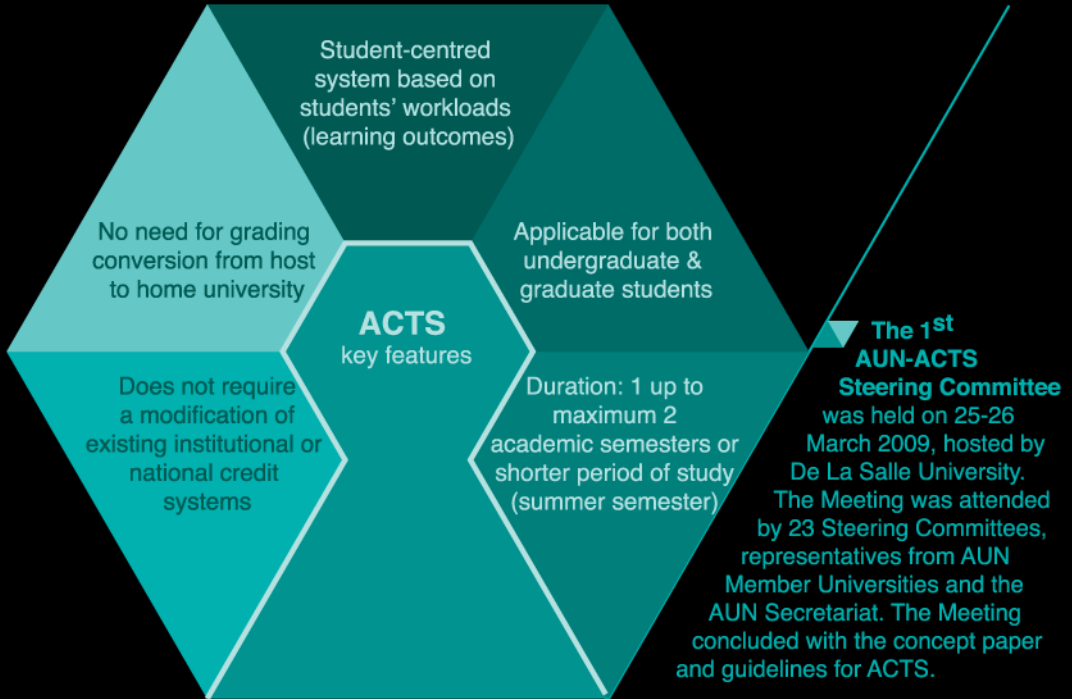
The Implementation of ASEAN Credit Transfer System (ACTS):



The difference between the various credit systems in ASEAN is considered as one of the main obstacles to the mobility and exchange of students within the region. By considering this factor, the AUN has developed and proposed the ASEAN Credit Transfer System (ACTS), a common credit transfer mechanism, to assist in facilitating and promoting academic mobility by focusing students' interests as a core of the process.

During 2009-2010, the AUN Secretariat in collaboration with AUN Member Universities organised a series of AUN-ACTS Steering Committee Meetings.





The 2nd AUN-ACTS Steering Committee was held on 19-20 January 2010. The Meeting was hosted by Vietnam National University-Ho Chi Minh City. The Meeting was attended by 30 Steering Committees, representatives from AUN Member Universities, the AUN-ACTS Secretariat and AUN Secretariat. The Meeting agreed to apply the ACTS mechanism to the AUN Student Exchange Programme and requested AUN Member Universities for its full scholarship contribution to the programme.

▶ The ACTS is targeted to be implemented among 22 AUN Member Universities by 2010 and ultimately, the ACTS scheme will be fully applied throughout the ASEAN after its integration in 2015.

Programme/Course Development ASEAN Studies Curriculum Design Workshop

In recognition of the growing awareness of ASEAN as a politically and economically important region, the East-West Center (EWC), Hawaii expressed its interests to foster a greater appreciation of regional commonalities and cooperation between ASEAN and U.S. by promoting ASEAN identity, integration of ASEAN and mutual understanding between two regions through education.



With the support from the East-West Center (EWC), Hawaii and the Asia-Europe Institute (AEI), University of Malaya, the ASEAN Studies Curriculum Design Workshop was organised in Kuala Lumpur on 3-5 September 2009.



The experts in ASEAN studies and related fields from 8 ASEAN countries namely, Brunei Darussalam, Indonesia, Lao PDR, Malaysia, the Philippines, Singapore, Thailand, Viet Nam and the representatives from the ASEAN Secretariat, the AUN Secretariat and East-West Center (EWC), Hawaii attended the workshop in order to share the experiences and knowledge and draw the structure of the ASEAN Studies Curriculum for the undergraduate level.





1st AUN Human Rights Education Network (AUN-HREN)

Building Human Rights Culture through AUN-HREN

The ratification of ASEAN Charter would not only promote the regional integration but also put the focus on strengthening the democracy, good governance and promotion of human rights and fundamental freedoms for ASEAN people. Considering the critical of human rights situation in the region, it is an essential need for ASEAN to support the initiative and promote human rights education and human rights studies within the region.

To achieve it, the AUN Secretariat with the support from the Center for Human Rights Studies and Social Development, Mahidol University, as a focal point of the network, collaborated to set up the AUN Human Rights Education Network (AUN-HREN). On 18-19 February 2010, the First Meeting of AUN-HREN was organised by the Center for Human Rights Studies and Social Development, Mahidol University. The Meeting was attended by 18 participants who have expertise on human rights and related areas, and the representatives from the AUN Secretariat and Raoul Wallenberg Institute, Sweden. The Meeting concluded with the AUN-HREN plan of activities 2010 and network's prioritised activities which focus on data accumulation, web-based resources, exchange programme, joint lecture and to develop ASEAN Human Rights teaching material.

The 2nd AUN Rectors' Conference "A strategic Management and New Challenges Ahead for University Collaboration"

Dates & Venue: 29 January 2009, Universiti Brunei Darussalam.

Host: Universiti Brunei Darussalam

Participation: Presidents, Rectors, Vice-Chancellors from 21 AUN Member Universities and also representatives from the SEAMEO Secretariat, SOM-ED, the ASEAN Secretariat, AUN's Sub-Networks, and the AUN Secretariats.

Outcome: the Conference was timely convened to address higher education strategic management issues which enhance the realisation of regional integration as embodied by ASEAN Community 2015 and discussed in three specific areas namely, Teaching Collaboration, Academic Collaboration: Joint Degree Programme, and Research Collaboration: Establishment of ASEAN Research Centre.



Feb'09

ASEAN-ROK Academic Conference

Date & Venue: 1-4 February 2009, Burapha University, Thailand

Participation: 44 speakers and discussants from ASEAN and the Republic of Korea

Theme: Pop Culture Formations across East Asia in the 21st Century: Hybridization or Asianization

Outcome: The ASEAN-Korean speakers presented their papers alternate with the valuable comments from the discussants in relation to the 5 sessions, namely

- 1) Cultural Industry in East Asia, 2) Politics of Popular Culture, 3) Social Differentiation and Pop Culture, 4) Pop Culture Market in Southeast Asia and 5) Pop Culture Market in Korea and Korean Wave. The participants deliberated and exchanged views on a common popular culture in the region and an emergence of Korean pop culture against the decline of Americanization. The paper presented at the conference was revised according to the inputs and comments of the discussants and then published in a book form.

1st AUN Rectors' Meeting

Date & Venue: 19 March 2009, Dusit Thani Laguna Resort, Phuket, Thailand

Host: The AUN Secretariat

Participation: It was the first informal gathering of the Presidents, Rectors, Vice-Chancellors of the AUN Member Universities.

Outcome: Two agendas on the amended AUN Charter and the Guidelines for AUN Memberships Enlargement were discussed. The amended AUN Charter had made pursuant to the establishment of the ASEAN Charter in which the ASEAN University Network was included in Annex 1 of the ASEAN Charter as one of the ASEAN Sectoral Ministerial Bodies to be functioned in accordance with the respective established mandate for the support of the ASEAN integration and community building.

ASEAN+3 Higher Policy Dialogue “Intellectual Contribution to Enhancing the Future Higher Education in East Asian Community”

Dates & Venue: 20-21 March 2009, Phuket, Thailand

Host: ASEAN University Network and the Ministry of Foreign Affairs, Thailand and the Office of Higher Education Commission, Thailand

Participation: A total of 79 Presidents, Rectors, Vice-Chancellors, representatives from 31 Participating Universities in ASEAN countries, China, Japan and the Republic of Korea, the ASEAN Secretariat and the AUN Secretariat.

Outcome: Throughout the 2-day Conference, the participants discussed mechanisms to intensify collaborative initiatives involving universities in the ASEAN+3 regions and made suggestions for forming a higher education framework to promote regional identity and solidarity in the region. At the end, the Forum agreed to establish an **ASEAN+3 University Network** which would be supported by the AUN Member Universities and the Participating Universities from Plus Three Countries. In order to ensure the success of this collaborative initiation, it was agreed to:

- ▀ convene the ASEAN+3 Rectors' Conference as well as the Meeting of Heads of IROs annually;
- ▀ enhance higher education networking, facilitate student and staff exchanges, encourage professional interactions and create research clusters;
- ▀ initiate the ASEAN+3 Collaborative Academic Programmes in various fields of Science & Technology, Art & Culture, Economics, ASEAN Studies and East Asian Studies;
- ▀ strengthen student mobility through the expansion of various existing activities;
- ▀ create a voluntary, non-intrusive credit transfer system; and
- ▀ develop micro sites within the AUN website which will serve as a regional IROs directory as well as database.

Task Force Meeting on AUN Membership Enlargement

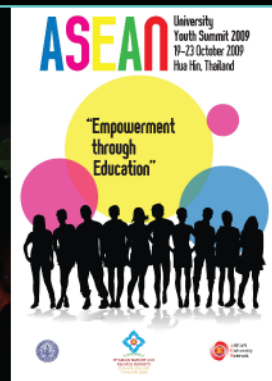


Date & Venue: 25 September 2009, Bangkok
Participation: 8 representatives from Universiti Brunei Darus salam, Gajah Mada University, University of Malaya, De La Salle University, Chulalongkorn University, Vietnam National University-Hanoi

Outcome: The Task Force revisited the AUN Charter and the existing process of and regulation for membership enlargement. After a thorough review of the relevant documents and the AUN's future prospect, prepared by the AUN Secretariat, the Task Force agreed to modify the structure and admission criteria of new membership in correspondence with some amended articles in the AUN Charter and requested the AUN Secretariat to work out in details of the operational guideline of the AUN Membership Enlargement and present to the Board Members for consideration.

Oct'09

ASEAN University Youth Summit



Date & Venue: 19-24 October 2009, Phetchaburi, Thailand

Host: Ministry of Foreign Affairs, Thailand

Participation: 20 student representatives from 10 ASEAN countries equally nominated by the ASEAN University Network (AUN) and the Ministry of Education in 10 ASEAN countries.

Theme: Empowerment through Education

Outcome: The 20 ASEAN youths energetically discussed and shared their views on how education plays a key role in their empowerment particularly in facing the challenges of the 21st Century as well as providing recommendations to policy makers the urgency to place education in the top of the agenda in the manner that will contribute to not only their development but that of society's. Their discussion was completely furnished in the form of the Joint Statement of the ASEAN Youth Summit 2009. On 23 October 2009, the ASEAN youths were given a chance to have an informal dialogue with the ASEAN Leaders and also attended the Ceremony to inaugurate the ASEAN Intergovernmental Commission on Human Rights (AICHR).

The 4th EU-Asia Higher Education Platform (EAHEP) Workshop on Quality Assurance in Asian and European Higher Education – Opportunities for Inter and Intra-Regional Cooperation

Date: 27-29 October 2009

Host: Chulalongkorn University

Participation: Around 40 universities representatives and experts from Asian countries and European Member States

Outcomes:

- Strengthening exchange and mutual learning (e.g. inviting peers as observers in QA assessments, comparative research studies, joint session on EU-Asia Cooperation at QA Forum, and etc.)
- Capacity building through seminars (train-the-trainer) and dialogue workshops on QA topics (e.g. learning outcomes)
- Link the networks together (European and Asian QA networks, university networks etc.)
- Increase stakeholders' involvement (promoting student involvement at all levels of QA processes)

Japan-ASEAN Student Conference



Background: Japan-ASEAN Student Conference is the event set up in accordance with Japanese Initiative found on the principle of people-to-people exchange under Japan-East Asia Network of Exchange of Students and Youths (JENESYS) Programme, established in 2007. This commendable Joint Statement shall then be submitted to the 13th ASEAN-Japan Summit in Viet Nam in 2010.

1st ACCESS Event on Students Involvement in University Management-An Interregional Dialogue



Dates & Venue: 2-3 February 2010, Bangkok, Thailand

Host: Chulalongkorn University

Participation: 40 representatives of university students and 20 representatives of executive academic staff and officers from the 8 ASEAN countries

Outcome: Two days of intense and open discussions, the participants acknowledged the importance of encouraging higher education cooperation, within Southeast Asia (SEA) as well as with the EU, as key to fostering mutual growth and development and to promoting regional integration and global competitiveness in a fast changing world. The event culminated in the production of a joint document containing a set of recommendations addressed to SEA, and EU policy makers, and to international organisations.

The 2nd AUN Rectors' Meeting

Dates & venues: 29 March 2010, Port Dickson, Malaysia

Host: University of Malaya

Participation: Presidents, Rectors, Vice-Chancellors and representatives of the 22 AUN Member Universities

Outcome: The Meeting took the opportunity to discuss the four main topics, related to the success and new challenges of regional cooperation under the leading light of AUN, including:

- 1) AUN Intellectual Property Network (AUNIP) in collaboration with EC-ASEAN Intellectual Property Rights Co-operation Programme (ECAP III), a project of innovation and learning development brought forth to promote the Intellectual Property (IP). A project structure was expanded to cover IP education, training and research institution and programmes within a common ASEAN-wide regional network to serve as a resource for IP education, policy research and formulation in the region.
- 2) The Implementation of ASEAN Credit Transfer System (ACTS), initiated by the AUN with an aim to propose and develop the common credit transfer mechanism to facilitate and promote the mobility of students in the region.
- 3) University's Social Responsibilities and Sustainability, initiated by the AUN with funding support from Japan Foundation to organise a workshop on "University's Social Responsibility and Sustainability from ASEAN-Japan Perspectives: Sharing and Caring for a Better Community".
- 4) An idea of establishment an ASEAN-ROK Cyber University was initiated by Dr. Surin Pitsuwan, Secretary-General of ASEAN with supported by the President of Korea, H.E. Mr. Lee Myung Bak. This initiation was agreed at the related ASEAN meetings on education. In light of this the AUN was tasked on behalf of ASEAN to organise the 1st Task Force Meeting on ASEAN-ROK Cyber University to explore the project feasibility and to develop the implementation plan of the project. Recommendation of the meeting will be presented to through the ASEAN Secretariat to the 13th ASEAN-ROK Summit in October 2010 for future consideration.

3rd ASEAN-China Rectors' Conference: Sharing Wisdom, Bridging Peoples' Minds

Dates & Venue: 30-31 March 2010, Port Dickson, Malaysia

Host: University of Malaya

Participation: 78 representatives (22 AUN Member Universities and 15 universities from P.R. China)

Theme: ASEAN-China: Sharing Wisdom, Bridging People's Minds

Outcome: The Conference was successfully organised with a strong support from the Ministry of Education, P.R. China, the Office of the Higher Education Commission, Ministry of Education Thailand, the ASEAN Secretariat and all dignitary participants. Both sides actively discussed on the collaborative activities under the ASEAN-China Academic Cooperation and Exchange Programme and agreed on the recommendation on the following ten topics that were of particular interest and relevant to China and ASEAN, namely Climate change, Water resource management, Infectious diseases, Energy, Crisis and disaster management, Human capital development, Cultural diversity, Language and linguistics Education management, Agriculture, and Traditional medicine. In achieving the concrete outcome of the ASEAN-China cooperation, the Conference recommended that the AUN Secretariat and Chinese focal points shall draft a Joint Action Plan including timelines and disseminate to the AUN and Chinese participating universities for consideration and endorsement. In this connection, the governments of ASEAN and P.R. China shall be urged to provide the financial support to the programmes/ projects/ activities initiated and developed under the ASEAN-China Academic Cooperation and Exchange Programme.

2nd ACCESS Event on Mobility as an Instrument for Integration: Sharing Experience and New Ideas.

Dates & Venue: 4-5 June 2010, Manila, the Philippines

Host: University of the Philippines

Participation: 36 academic affairs executives and ICT experts from AUN Member Universities from Brunei Darussalam, Indonesia, Malaysia, the Philippines, Singapore, Thailand, Viet Nam and ACCESS Partners namely MENON Network, Southeast Asian Association for Institutional Research (SEAAIR), European Students' Union (ESU), Universidad Politecnica de Valencia (UPV) and University of Reading.

Outcome: 2-day conference and workshop, participants exchanged their ideas on the way to increase student mobility between ASEAN and Europe by exploring the existing practices and proposing the prospective ways of cooperation in order to promote both physical and virtual mobility. The conference agreed to the establishment of the ASEAN-EU Mobility Framework for Sustainable Implementation which prioritised by the following areas of cooperation; the Student Exchange, Faculty Staff Exchange, Role of ICT, Credit Transfer System, Quality Assurance, and Resource and Knowledge Exchange. The Framework would be submitted to the 2nd ASEM Rectors' Conference and other ASEAN and the EU policy meetings for further support.

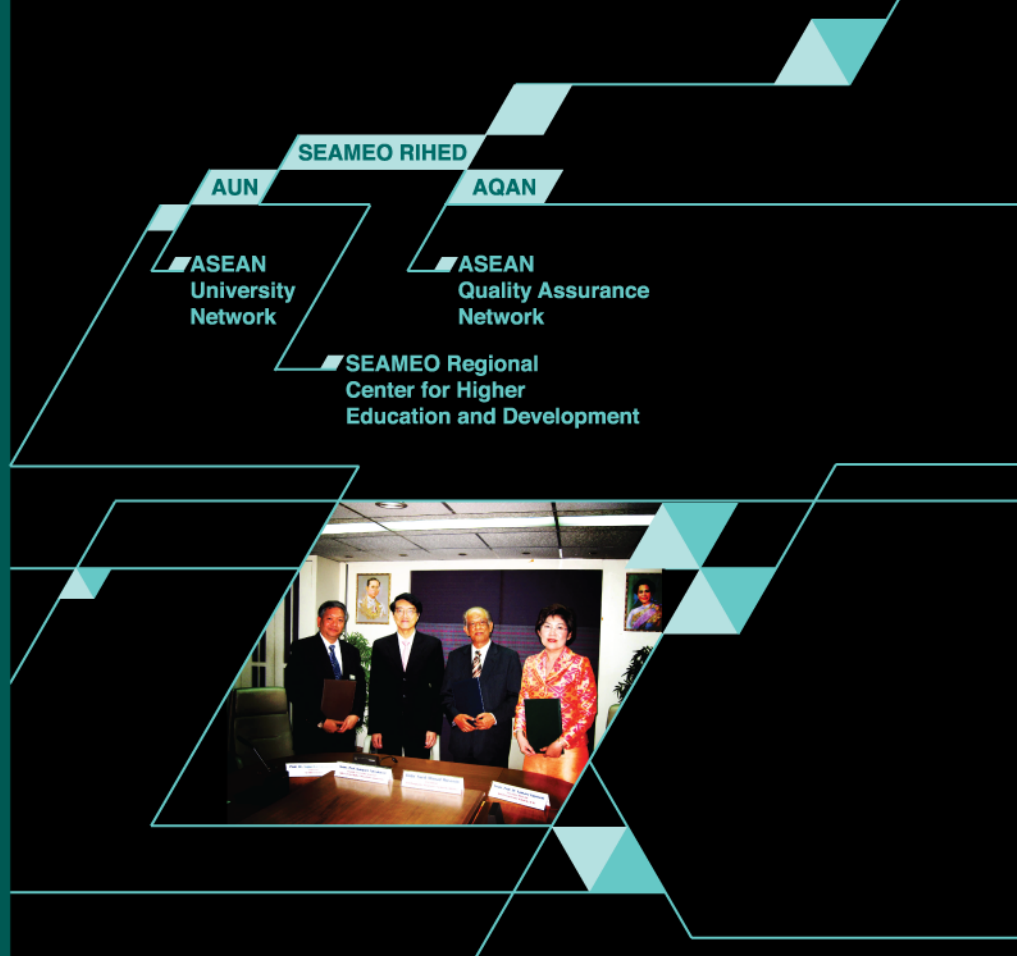
Meeting on “AQAN-AUN-SEAMEO RIHED: Tripartite QA Synergistic Relationship”

Date: 15 June 2010, Bangkok, Thailand

Host: SEAMEO-RIHED Secretariat

Participants: 12 participants from SEAMEO-RIHED, AQAN, AUN, Bureau of International Cooperation Strategy, Bureau of Standards and Evaluation, Office of the Higher Education Commission, discussed and exchanged experiences on their quality assurance works and determined the strategic cooperation for the future quality assurance direction in the region.

Outcome: 3 parties (AQAN, AUN, SEAMEO-RIHED) agreed to sign the Partnership Statement of the Synergistic Relationship among **AQAN-AUN-SEAMEO RIHED** for being regional alliance partners in the promotion and enhancement of quality assurance for education.





AUN Sub-networks' Activities

AUN Sub-networks operate and manage autonomously under the AUN scheme. Having their own secretariat, AUN Sub-networks are responsible for specific projects and areas. Each network has to report its annual activities to the AUN Board of Trustees for acknowledgement. Five sub-networks under AUN are:

- ASEAN Graduated Business and Economics Programme(AGBEP) Network
- AUN Human Rights Education Network (AUN HREN)
- AUN Inter-Library Online (AUNILO)
- AUN Intellectual Property Network (AUNIP)



AUN Southeast Asia Engineering Education Development Network (AUN/SEED-Net)

Secretariat: Faculty of Engineering, Chulalongkorn University, Thailand

Roles: This sub-network, mainly supported by the government of Japan through the Japan International Cooperation Agency (JICA) and partially supported by ASEAN Foundation, focuses on promoting human resources development in engineering in ASEAN through academic collaboration between 19 leading Member Institutions from ASEAN and 11 leading Japanese Supporting Universities. The key activities are the exchange of students, faculty members and knowledge through various activities including Scholarship for Master Degree Programmes, PhD Sandwich Programmes, Japanese Professors Dispatch, Collaborative Research, Short-term Visits and Regional Conferences. To date, AUN/SEED-Net has the proven achievement in accordance with its key objective as illustrated in the significant number of graduates in all of its programmes which are 352 graduates in total.

-On 6 November 2009, The 16th Steering Committee Meeting was convened in Hanoi, Vietnam. The main focuses of the Meeting were to review the activities of Phase II and to prepare for the groundwork for the network's future in Phase III after March 2013. In this regard, the 20-year plan of the network (March 2003-March 2023) was presented and carefully deliberated by AUN/SEED-Net stakeholders to make a decision for the forthcoming steps of the network. The resolution for the future framework is expected to be concluded by next year.

ASEAN Graduated Business and Economics Programme(AGBEP) Network

Secretariat: De La Salle University, the Philippines

Roles: This sub-network was established with the main objectives to internationalise and improve quality of graduate business programme of institutional members.

During 2009-2010, the AGBEP Secretariat and AUN Member Universities jointly organised 2 annual meetings;

The 9th Annual AGBEP Network Meeting was held on 15-16 January 2009 hosted by De La Salle University. The Meeting was attended by 27 representatives from AGBEP Institutional Members, the AGBEP Secretariat and the AUN Secretariat. Components of the annual meeting were; the discussion on the postponement of the Inaugural ASEAN Cooperation on Economics and Business Education (ACEBE), invitation guest lecturers and academic seminars. The Meeting also acknowledged Prof. Myrna S. Austria as the new Chairperson of the AGBEP Secretariat.

The 10th Annual AGBEP Network Meeting was held on 18-19 January 2010, hosted by Vietnam National University-Ho Chi Minh City. The Meeting was attended by around 35 representatives from AGBEP Institutional Members, the AGBEP Secretariat and the AUN Secretariat. The Meeting discussed on prospective joint course in the area of global networking, Asian management, international trade policy and cross cultural policy. Also the Meeting agreed to enhance its position to serve not only network members but to serve as a "Think Tank" body for the ASEAN Economic Community.

AUN Human Rights Education Network (AUN HREN)

Secretariat: Center for Human Rights Studies and Social Development, Mahidol University, Thailand, serves as the focal point for the AUN-HREN

Roles: The AUN sub-network on Human Rights Education will operate under the followings objectives;

- to establish and strengthen the network of experts and scholars in the area of human rights studies and other related areas;
- to promote education and research opportunities in the area of human rights among AUN Member Universities
- to enhance capacity of AUN Member Universities in developing curricular/ programme or course in Human Rights and related fields;
- to raise human rights awareness and enhance regional cooperation that will lead to better protection and promotion of human rights and fundamental freedoms;
- to jointly organise capacity building activities including, training, workshop, seminar, conference and exchange programme, and
- to collaborate with the AUN Secretariat and Member Universities to set up the meeting of AUN Human Rights Education Network (AUN-HREN) as well as disseminate relevant information regarding human rights to the members.

AUN Inter-Library Online (AUNILo)

Secretariat: University Sains Malaysia Library, Malaysia

Roles: This sub-network focuses on utilisation ICT in education through the information networking programmes. This includes establishment and development of online information exchange system within Member Universities. Various initiatives to enhance information sharing and dissemination have been launched since AUNILo's official establishment in 2003.

- The 6th AUNILo Committee Meeting was held during 7-9 April 2010 in Jakarta hosted by Universitas Indonesia with the theme entitled "Building Portal, Bridging Nations". Reflecting the Meeting theme, the main focus was to establish the Portal as the main system for information and materials sharing among member institutions.

- The Meeting concluded that all member institutions agree to share the contents of their Institutional Repositories (IRs) subject to the legislation of their country as well as terms and level of access as decided by their parent institution. Survey of availability of IRs will be conducted in all member institutions. The Meeting also concurred that compiling a bibliography on a topic of common interest to be conducted with the minimum level of access to bibliographic record and abstract of items. In overseeing the inception of AUNILo Portal, all member institutions will pool financial support for continuous enhancement and maintenance of the Portal.

AUN Intellectual Property Network (AUNIP)

Secretariat: Chulalongkorn University Intellectual Property Institute (CUIPI)

Role: The network on IP was established as a sub-network of the AUN named as “the ASEAN University Network Intellectual Property Network” or “AUNIP”.

- With the support from the ECAPII and Chulalongkorn University, the AUN organised the “ECAPII/AUN Regional Conference on IP Education and Networking” on 28-30 May 2007. Scholars from 12 AUN member universities; namely, the Universiti Brunei Darussalam, Gadjah Mada University, University of Indonesian, National University of Laos, University of Malaya, Universiti Sains Malaysia, University of the Philippines, Nanyang Technological University, Chulalongkorn University, Burapha University, Mahidol University and Vietnam National University-Ho Chi Minh City attended the Conference. As a result of the ECAPII/AUN Regional Conference on IP Education and Networking organised in Bangkok in May 2007, the representatives agreed that network and partnership on IP should be established in the ASEAN region. Hence, the network on IP was established as a sub-network of the AUN named as “the ASEAN University Network Intellectual Property Network” or “AUNIP”.

- The AUNIP comprises 19 members of the AUN and shall enlarge at a later stage upon agreement of existing members. The AUNIP has main responsibility of enhancing IP knowledge in the region through the organisation of workshops/conferences and establishing relationship with other IP networks. It has been agreed that the AUNIP Meeting will be organised annually so that scheme of IP education would be developed.

- The establishment of the AUNIP came into effect through the signing of the Memorandum of Understanding (MOU) on 30 May 2007. The AUNIP’s main objectives are:

- To enhance IP knowledge in the ASEAN region;
- To raise the quality of IP education and research in the ASEAN region;
- To assist both AUN and non-AUN Member Universities in developing IP curriculum and teaching materials for courses offered to law and non-law students; and
- To organize innovative and high quality conferences and research seminars on significant contemporary IP developments.

- The 2nd AUNIP Board Meeting was hosted by the University of Malaya (UM) on 14 January 2009 at Hilton Petaling Jaya Hotel, Kuala Lumpur. The Meeting was attended by the AUNIP Board Members and representatives from Universiti Brunei Darussalam, the National University of Laos, the University of Malaya, Universiti Sains Malaysia, De La Salle University, Ateneo de Manila University, the National University of Singapore, Nanyang Technological University, Chulalongkorn University, Mahidol University, AUN and AUNIP Secretariats.

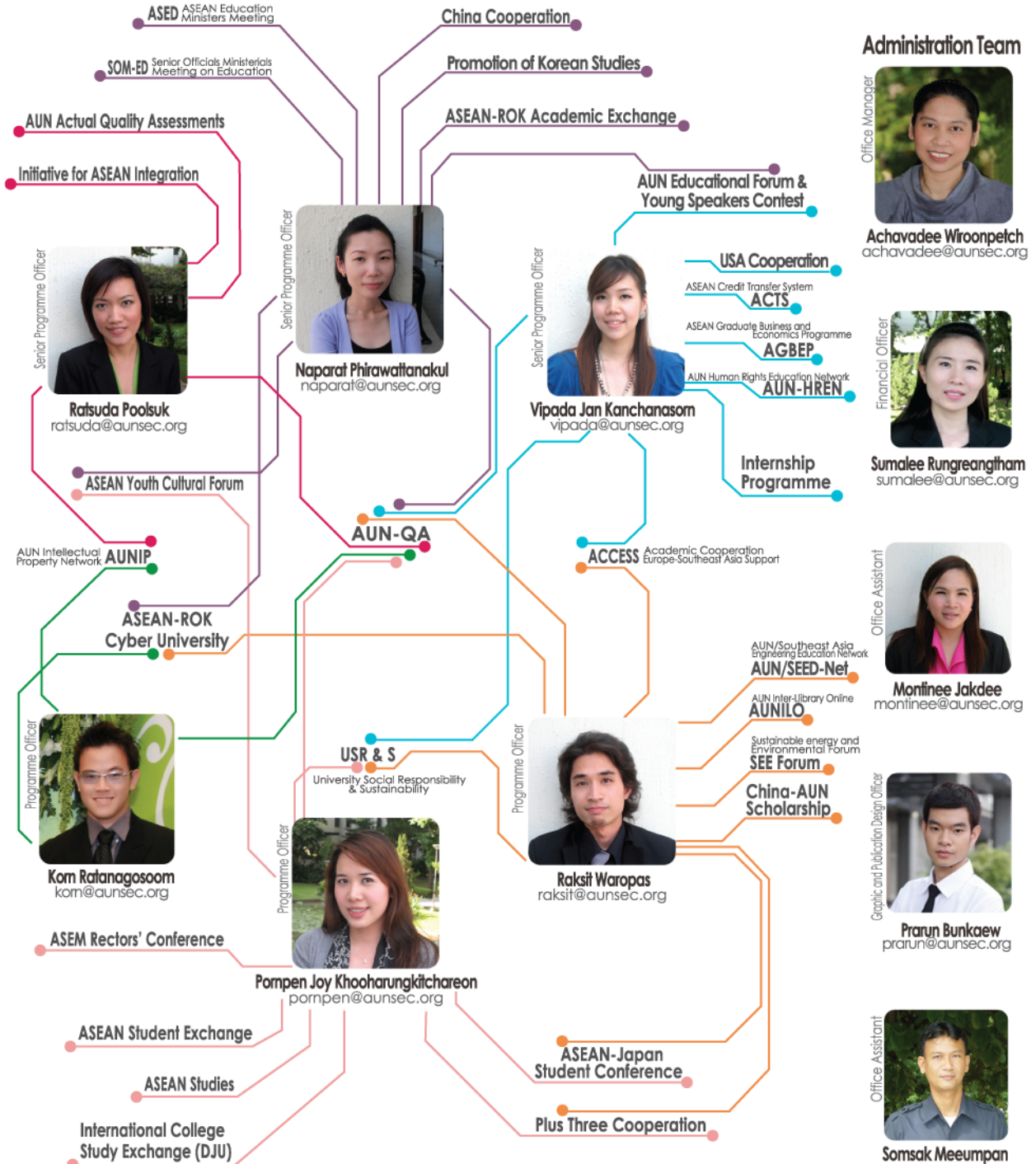
